Paragraph B.

Terms and Conditions of Service

Applicant agrees to the following:

1. To connect to and/or utilize District services as they are made available and to pay all charges (including, but not limited to: Facilities and service charges, availability charges, connection and reconnection charges, tap-on fees, bond and/or debt payments, fees, deposits, taxes, assessments (including special assessments due to unanticipated interconnection or annexation costs) and/or all other billings costs, including collection costs and reasonable legal fees necessary to the collection of same) required by the Ordinances, Resolutions, and Policies presently in force or hereafter adopted by the District.

2. To install and maintain any necessary, proper, or required plumbing, wiring, utility, interconnect, device, hardware, or fixture as required by the District for provision of service.
3. To grant and convey perpetual easement to the District or its assigns and to allow free access to Property listed in Paragraph A. and all other lands owned by applicant having common border to Property for the purposes of: installing, operating, maintaining or examining, measuring, monitoring, or disconnecting any District service (including water, sewer, drainage and solid waste). All excavations shall be completed in such a manner as to leave the ground surface in substantially the same condition that existed before work by the District was begun and all surplus construction debris shall be removed from the premises. Installations not necessary to provide service solely to residence and adjacent properties shall be made within fifteen feet (15') of property lines unless provided for in a separately defined easement or right-of-way.
4. This application is subject to the acceptance and approval of the District and may be refused wholly or in part.
5. Property is within the boundaries of the District.
